About Davangere University

Davangere University is one of the youngest affiliating types of Universities in Karnataka. It has a jurisdiction of two Districts viz., Davangere and Chitradurga and headquartered at Davangere. Davangere which was part of Chitradurga District became a separate district on 15th August 1997 and is emerging as an important educational centre besides being a well known commercial and industrial town in Karnataka. Davangere University prior to its establishment functioned as a Post-Graduate Centre of the University of Mysore from 1979 to 1987. Later, with the establishment of Kuvempu University in 1987, the P.G. Center came under the jurisdiction of the new university due to its geographical location and hence functioned as its P.G. Centre from 1987 to 2009. Davangere University was established (with a Gazette Notification from the Government of Karnataka) on 18th August 2009 by being carved out of Kuvempu University with apurpose and vision to meet the educational aspirations of the people of this region. The University has four Faculties viz., (i) Arts, (ii) Science & Technology, (iii) Commerce & Management, and (iv) Education. It has 30 Post-Graduate Departments of Studies and Research on the main campus offering 28 Post-graduate Programmes and a few Diploma Courses.

About RSVP

Rashtriya Samaj Vigyan Parishad (RSVP) founded in 2008, duly registered in New Delhi under the National Registrar Societies Act 1860, is a national scholarly association devoted to the cause of learning, revising and reconstructing the subjects of social sciences in consonance with classical Indian thought and philosophy. In a threadbare introspection and deliberations conducted by 100 renowned Indian Social Scientists in Rambhau Mahalagi Prabodhini, Mumbaiin 2008, it was realized that despite several decades of independence from colonialism 'intellectual servitude' still permeates the academic arena of our country. Whether it is economics or sociology, history or politics, the predominance of Eurocentric premises, assumptions and philosophical postulates have led to large scale mimicry in teaching and research, which often areirrelevant to Indian sociocultural realities. Unfortunately, despite India's rich tradition of indigenous knowledge, the concepts of social sciences and the ideas related to the various disciplines have not been based upon it. Indian values, philosophy and culture are scarcely reflected in the subjects of social sciences and nor has social sciences holistically contributed in generating a spirit of national pride. Therefore, it was unanimously decided to create RSVP in order to address these issues through a proper reorientation of social sciences which could cater to the structural dynamics and functional subtleties of Indian society in particular and the world at large. Ever since, RSVP has been engaging seriously in augmenting the reversal of the analytical gaze, which hitherto has been from the west to the east and normally privileges the former. In its attempt to strengthen the indigenization base of social sciences in India, RSVP has been organizing conferences, seminars, workshops, symposia and intellectual appeals across the country. The impetus is not just to comprehend and condition ourselves to the social environment but to improve, enrich and make it better than what it is today. Scholarly endeavours have been stimulated to promote thoughtful analysis of pertinent questions and larger societal issues confronting the present milieu by replacing the existing trend of knowing via the west with alternative perspectives which are more culturally relevant and socially acceptable and adaptable. In its efforts to broaden interdisciplinary collaboration among the social sciences, RSVP engages in fostering collection, interpretation, analysis and dissemination of data on socialscience resources and also promotes native scholarship to galvanize the nation building process. Linking social sciences knowledge effectively to public policies and local needs in order to improve the quality of people's lives, is also its major purported aim.

About the Conference

Indigenization of social science- the movement towards establishing social science focusing on the intellectual and cultural traditions of the native people of a given society has been

resilient since a few decades, originating from Asia cultural studies. The argument, essentially, has been in favour of comprehensively understanding the history, language, health and wellness, creative arts, spirituality, traditional knowledge system, community dynamics, literature, etc. in the process of social theorization and knowledge building. Like in several developing societies, Indian intellectual community also has been working in building social science 'for India, 'in India' and 'of India' albeit with limited success, to put it succinctly. While there have been plenty of criticisms against" colonial mindset" of our social science there have not been many concrete suggestions to make them more dependable, reliable and pertinent.

It is a known fact that with a few honorable exceptions, Indian social scientists have not been able to make substantial contribution to the understanding of Indian society in general and not been able to unravel major national issues. One of the basic reasons for Indian Social Science's relative lack of authenticity and relevance in understanding all-inclusive Indian Relatives has been its Eurocentric nature of perception to Indian social system and structure. Our colonial legacy and repeated invasions of outside cultural assaults have contributed to our alien academic mindset. Given this predicament, social science in India has been largely "foreigner" and "outside" to Indian worldview in general, resulting in its inadequacy of credibility and legitimacy in suggesting tunable explanations and answers. Such a situation has put social sciences on a slippery ground and increasingly necessitated "Indianization of social sciences". One of the basic questions that arise in the vital area of social science teaching and research today is how and much relevant are they in our present societal context. This questions needs to be answered by making use of our indigenous knowledge systems and manifestation of popular wisdom. This two- day National Seminar purports to look into this issue constructively.

Subjects Such as,(a) Teaching in the National language. (b) Research by insiders vis-à-vis outsiders. (c) Determination of research priorities. (d) Methodological re-orientation. (e) Use of native material to cognize social concerns are needed to be debated constructively and productively in social science teaching and research.

Objectives of the Conference

The objectives of the proposed conference are as follows:

This conference is aimed at develop a clear understanding of effective use of Indigenization Social Sciences in research and teaching. Hence, the schedule of the conference is aimed at theoretical understanding of social sciences followed by thorough different technical sessions. The primary objective is to impart awareness to the Social Science scholars and students on how to carry out Indigenization issues and methods to draw reliable and meaningful studies. Hopefully, by the end of the conference participants will be able to develop conceptual clarity regarding indigenous social studies and knowledge for analysis and interpreting the social issues for their research and teaching.
