DRAFT STATUTES GOVERNING THE RULES/GUIDELINES FOR THE RECRUITMENT OF NON-TEACHING POSTS (Deputy Registrar; Assistant Registrar; Superintendent; Senior Assistant; Assistant/FDA; Stenographer; SDA/Junior Assistant; Computer Programmer; Computer Operator and other Non-Teaching Posts) IN DAVANGERE UNIVERSITY.

(The Statutes are framed under section 40 (k) and 41 of KSU Act 2000)

PREAMBLE:

- 1. This University came into existence on 18.08.2009, comprising of two Districts, namely, Davangere & Chitradurga. To fulfill the Academic interest and desire of Student Community and the Public in general, this University has established various Post-Graduate Programmes at University Campus, Shiva Gangothri Campus, Davanagere and also in the Post-Graduate Centre, Jnana Gangothri, Chitradurga.
- 2. The Department of Higher Education, Government of Karnataka, has sanctioned 100 Teaching Posts and 98 Non-Teaching posts for the newly established Post-Graduate Departments, University Administration, Examination, Finance and other subordinate offices of the University to meet the Administrative/Examination/Finance workload prevailed in the various Offices of the University. It has also permitted to fill up certain NON-TEACHING POSTS sanctioned for the University Administration, Examination, Finance and other P.G. Departments which are in existence at present in this University. His Excellency the Chancellor of Davanagere University and also the Governor of the Karnataka has also accorded approval to fill up Teaching and Non-Teaching Posts vide letter No:GS-03-DUM-2017 Dated:01.03.2017.
- 3. Further, the Department of Higher Education, Government of Karnataka, has prescribed and circulated Draft Rules/Guidelines relating to Recruitment of Non-Teaching Posts the University Authorities have decided to incorporate the Rules/Guidelines prescribed by the Government and also decided to follow the same while making recruitments to the Non-Teaching posts in the University.

DRAFT STATUTES

PART - A

I. TITLE:

These Statutes shall be called as the Statutes Governing the Rules/Guidelines for the Recruitment of Non-Teaching Posts (SDA/Junior Assistant, Assistant, FDA/Senior Assistant, Stenographer, Computer Programmer, Computer Operator, Assistant Registrar, Deputy Registrar, Office Superintendent, etc.) required in various newly established Post-Graduate Departments, University Administration, Examination, Finance and other subordinate Offices of the University to meet the Administrative/Examination/Finance workload in Davangere University.

II. COMMENCEMENT:

- a) These Statutes shall come in to force from the date of Assent of His Excellency the Chancellor of Davangere University.
- b) Notwithstanding anything contained at (a) above, these Statutes shall deemed to have been approved from the date of circulation of Rules/Guidelines by the Department of Higher Education, Government of Karnataka

III. DEFFINITIONS:

- 1. "University" means Davangere University as prescribed under Section 3(d) of KSU Act 2000
- 2. "Syndicate" The Syndicate of Davangere University as prescribed under Section 28(1) of KSU Act 2000
- 3. "Academic Council" means The Academic Council of Davangere University as prescribed under Section 30(1) of KSU Act 2000
- 4. "Finance Committee" means The Finance Committee of Davangere University as prescribed under Section 32(1) of KSU Act 2000

IV. SELECTION COMMITTEE FOR THE APPOINTMENT OF NON-TEACHING AND OTHER POSTS:

"Board of Appointment" means - The Board of Appointment Committee prescribed under section 57 of KSU Act 2000 or as per the guidelines/rules prescribed by the Government of Karnataka.

PART - B

V. QUALIFICATIONS AND METHOD OF RECRUITMENT:

The Non-Teaching Posts shall be filled up as per the qualifications prescribed by the University Statutes/Government of Karnataka. The Method of Recruitment shall be as prescribed by the Statutes/Karnataka State, Universities Act 2000 Under Section 57 OR as per the Recruitment Rules prescribed by the Government of Karnataka, the University shall also follow the orders of the Government of Karnataka issued from time to time.

VI. RESERVATION OF POSTS:

The Selection Committee shall follow the Orders of the Government of the Karnataka issued from time to time with regard to the fixation of Roster while preparing the Select List of Candidates.

PART - C.

1. APPLICABILITY OF RULES/GUIDELINES PRESCRIBED FOR RECRUITMENT OF NON-TEACHING POSTS:

These guidelines are applicable for the recruitment of *Deputy Registrar*; Assistant Registrar; Superintendent; Senior Assistant; Assistant/FDA; Stenographer; SDA/Junior Assistant; Computer Programmer; Computer Operator and other Non-Teaching Posts etc. as per the KCS (General Recruitment) Rules 1977 as amended from time to time.

The recruitment of Non-Teaching posts shall be based on a Written Test without any weight-age for Academic Performance. The Written Test may consist of General Knowledge and Aptitude; Language - Proficiency in Kannada & English; Knowledge of Computers and Service Rules etc. The Written Test shall consist of Objective Type Questions.

2. PROCEDURE: (Qualifying Examination for Candidates)

For the purpose of Written test of Non -Teaching Posts, as suggested in the Circular No:ED:136:UNE:2017, Dated:17.07.2017 of the Department of Higher Education, Government of Karnataka, a Multiple Choice Question Bank and Keys will be generated consisting of General Knowledge and Aptitude Test, Language Proficiency in Kannada and English, Knowledge of Computers and Service Rules etc. for the Conduction of Entrance Examination the University shall follow the Regulations framed for this purpose.

- a) Regular Procedures will be followed to select and print the question paper as well as for processing of OMR sheets.
- b) The University shall prepare the merit list after examination based on the state Government Circular.
- c) The Merit List shall be announced in the University website and displayed in the University Notice Board. In case of any discrepancy, the Candidate has the right to approach the concerned authorities within 7 days from the date issuance of Notice
- d) Based on the Merit List, DOMAIN KNOWLEDGE TEST shall be called in the ratio of 1:3.
- e) Domain knowledge test for 9.8 marks will be conducted for the candidates by the BOA as per the Karnataka State University Act 2000 and the result will be announced on the same day.
- f) The appointments in respect of "C" and "D" Posts shall be made only on the basis of MERIT without conducting Domain Knowledge Test.

VIII. MODIFICATIONS OF THE STATUTE:

Notwithstanding the foregoing, the orders of the Government of Karnataka issued from time to time, shall be deemed to have been incorporated in this statute and shall constitute an integral part of this Statutes.

IX. REMOVAL OF DIFFICULTIES:

In case of any difficulty arises in the implementation of these Statutes, the Vice-Chancellor may take such an action as he may deem fit in each case, duly recording the reasons for taking such a decision.
