

ORDINANCES GOVERNING THE PROCEDURE FOR REVALUATION/ CHALLENGE VALUATION OF ANSWER BOOKS OF THE UNIVERSITY EXAMINATIONS.

(These Ordinances have been framed as per Section 42 (1) (e) of K.S.U. Act 2000)

PREAMBLE:

- 1) This is an Affiliating type of University came into existence with effect from 18.08.2009. This has a Higher Education Territorial Jurisdiction in the Districts of Davangere and Chitradurga with its headquarters at Davangere, located at Shiva Gangothri Campus, Davangere.
- 2) The University Grants Commission (UGC), New Delhi, has recognized this University under Section 2 (b) and 12 (f) and 22 of UGC Act – 1956, for the purpose of sanctioning UGC Development Assistance/Salary Components/ Research Grants and recognition of various Graduate and Post-Graduate Degrees conferred by this University from time to time.
- 3) This University has 31 Post-Graduate Departments of Studies and Research in the faculties of Arts; Commerce & Management; Education and Science and Technology – established at the Main Campus Shivagangotri, Davangere and also at the Post-Graduate Centre, Jnanagangotri Campus, G.R. Halli, Chitradurga. There are also 125 Affiliated First Grade Colleges coming under the jurisdiction of this (in Davangere and Chitradurga districts) University, impart teaching at P.G. Diploma/ Graduate and Post Graduate Courses.

- 4) It is the legitimate responsibility of the University to conduct/hold Examinations at P.G. Diploma/ Graduate/Post-Graduate levels and Grant/ Confer Degrees/ Diplomas **or** other Academic distinctions to the Candidates as per the Academic Regulations relating to P.G. Diploma, Graduate/ Post-Graduate Courses of the University. The following Regulations have been formulated as per the provisions stipulated under Section 4 (ii) (a) of Karnataka State Universities (KSU) Act-2000.
- 5) The Syndicate of the University as per Section 29 (2) (d) and the Academic Council under Section 31 (iii) (iv) of KSU Act-2000 have formulated the following Ordinances for the purpose of smooth conduction of University Examinations at Graduate and Post-Graduate level in all its Affiliated Colleges; Constituent Colleges and Post-Graduate Departments of the University in a very transparent, fair manner and also to implement and follow the procedure with regard to Revaluation/Challenge Valuation of Answer Books in respect of enrolled Candidates those appeared for various University Examinations conducted by Davangere University at P.G. Diploma/ Graduate/Post-Graduate Semester End/Year End Examinations.

Pursuant to the approval to these Ordinances by the Syndicate in its Meeting held on 31.07.2023 and the Academic Council in its Meeting held on 11.08.2023 the Vice-Chancellor has accorded approval on 11.08.2023 to take suitable steps for onward submission to His Excellency the Chancellor for kind approval.

HENCE, THESE ORDINANCES,

SECTION - A

I. TITLE:

These Ordinances shall be called as the "Ordinances Governing Revaluation/ Challenge Valuation of Answer Books of University Examinations".

II. COMMENCEMENT:

These Ordinances shall come into force from the date of approval of His Excellency the Chancellor.

III. DEFINITIONS:

1. "**University**" means - the Davangere University established by the Department of Higher Education, Government of Karnataka - as prescribed under Section 3(d) of KSU Act 2000.
2. "**Syndicate**" - the Syndicate of Davangere University as prescribed under Section 28 (1) and powers conferred under Section 29 of KSU Act - 2000.
3. "**Academic Council**" means - the Academic Council of Davangere University as prescribed under Section 30 (1) and powers conferred under Section 31 of KSU Act -2000.
4. "**Post-Graduate Departments**" means - the Post-Graduate Departments established by the University at its Campus, Post-Graduate Centres, its Constituent Colleges run and maintained by it and also established in Affiliated Colleges, with the approval of the Government of Karnataka and also Affiliated by the University.

5. **“University Examinations”** means - the Examinations conducted for all Post Graduate, Graduate, P.G. Diploma and Certificate Courses under Semester / Non Semester Schemes, established as per the respective Academic Regulations of the University.
6. **“Ordinances” means** - the Ordinances framed by the University Syndicate to implement the procedure relating to Examinations conducted by the University and further Revaluation and also Challenge Valuation of Answer Scripts of the Examination held in that particular Academic year.

SECTION - B

ORDINANCES:

ORD-1: GENERAL TERMS AND CONDITIONS THAT APPLY FOR REVALUATION/CHALLENGE VALUATION:

- 1) The Student shall apply for Revaluation / Challenge Valuation of Theory Papers within 10 days from the date of declaration of results.
- 2) The student shall apply for Revaluation / Challenge Valuation for a maximum of 02 Papers/ Subjects per Semester **or** per Examination in Non-semester.
- 3) If the course has optional subjects with 02 **or** more than 02 papers, the Student shall apply for Revaluation/ Challenge Valuation to a maximum of 02 Papers in the same optional subject **or** One each from different optional Subjects but not exceeding Two Papers overall in a Semester **or** per Examination in Non-semester.
- 4) The Papers/ Subjects applied for Revaluation shall be different from the subjects opted for Challenge Valuation.

- 5) The Regular Students shall submit the Application for Revaluation/ Challenge Valuation/ Re-totalling along with the Original/ Computer generated self-attested marks statement to the Principal of the College/ Chairman of P.G. Department/ Administrator of P.G. Centre for onward transmission to the University Examination Branch.
- 6) The External Students shall submit the Applications for Revaluation/ Challenge Valuation/ Re- totalling directly to the University Examination Branch.
- 7) There is no restriction on the marks obtained by the Candidate for applying for Revaluation/ Challenge Valuation of Theory Subjects/ Papers.
- 8) **FEE:** The Fee for Revaluation/ Challenge Valuation as prescribed by the University may be subject to change from time to time as per the existing Ordinance.

ORD-2: MODE OF REVALUATION/ CHALLENGE VALUATION OF VARIOUS DEGREE COURSES CONDUCTED BY DAVANGERE UNIVERSITY

A. ALL POST-GRADUATE COURSES:

The Candidates shall opt for Revaluation/ Challenge Valuation for a maximum of 02 (Two) Papers / Subjects per Semester but not exceeding 04 times in Two-Year Degree Course and 06 times in Three-Year Degree Course **or** 08 times in Four Year Degree Course. The Papers/ Subjects opted for Revaluation and Challenge Valuation need not be the same.

B. ALL P.G DIPLOMAS/CERTIFICATE COURSE ETC:

The Candidates shall opt for Revaluation/ Challenge Valuation for a maximum of 02 (Two) Papers/ Subjects per Semester [but not exceeding 04 (Four) times in Two-Year

Degree Course and 08 (Eight) times in 4-Year Degree Course] and 02 (Two) times in One-Year Course. The Papers/ Subjects opted for Revaluation and Challenge Valuation need not be the same.

C. ALL UNDERGRADUATE COURSES:

The Candidates shall opt for Revaluation/ Challenge Valuation for a maximum of 02 (Two) Papers/ Subjects per Semester but not exceeding 06 (Six) times in Three Years Degree Course **or** 08 (Eight) times in 4-Year Degree Course. The Papers/ Subjects opted for Revaluation and Challenge Valuation need not be the same.

D. B.Ed./ B. P. Ed. COURSES:

The Candidates shall opt for Revaluation/ Challenge Valuation for a maximum of 02 (Two) Papers/ Subjects per Semester but not exceeding 04 (Four) times in Two-Year Degree Course. The Papers/ Subjects opted for Revaluation and Challenge Valuation need not be the same.

E. ALL NON-SEMESTER COURSES:

The Candidates shall opt for Revaluation/ Challenge Valuation for a maximum of 02 (Two) Papers/ Subjects per Examination but not exceeding the number of times equivalent to the total duration (in years) of the Course. The Papers/ Subjects opted for Revaluation and Challenge Valuation need not be the same.

F. ANY OTHER COURSES NOT COVERED ABOVE:

For any Post-Graduate Degree Graduate/ P.G Diploma/ Certificate Course not covered above, the Candidates shall apply for Revaluation/ Challenge Valuation for a

maximum of 02 (Two) Papers/ Subjects per Semester / Year not exceeding the number of times equivalent to the total number of Semesters/ Years of the Course. The Papers/Subjects opted for Revaluation and Challenge Valuation need not be the same.

SECTION - C

ORD-1: NATURE OF THE PAPERS/ SUBJECTS PERMITTED FOR REVALUATION/ CHALLENGE VALUATION:

- a) Revaluation/Challenge Valuation is permitted for Theory Papers/ Subjects only. It is not applicable for Dissertation, Practical, Project Work, OMR etc.
- b) There shall not be any provision for Revaluation of the Answer Papers which are already evaluated by Two Examiners (i.e., double valuation). However, the Candidate may apply for Challenge Valuation.

ORD-2: PROHIBITION OF CHALLENGE VALUATION AFTER REVALUATION RESULTS.

There is no provision for Challenge Valuation after the declaration of Revaluation Results. In case, if the Candidates are not satisfied with Revaluation Result, HE/SHE may make an Appeal to the Vice-Chancellor for review of Revaluation Results.

ORD-3: PROVISION FOR RE - TOTALING OF THE MARKS.

The Candidates may opt for re-totaling of marks obtained in any number of Theory papers including papers / subjects applied for Revaluation / Challenge Valuation. However, there is no provision for re-totaling of marks for Dissertation, Practical, Project work, OMR and *digitally valued papers*.

ORD-4: ARRANGEMENT FOR REVALUATION/ CHALLENGE VALUATION.

The Revaluation / Challenge Valuation shall be conducted by the Co-ordinator appointed by the Vice Chancellor of the University. He shall be assisted by the required number of supporting staff.

ORD-5: SELECTION OF EXAMINERS FOR REVALUATION/ CHALLENGE VALUATION.

The Answer books for Revaluation/ Challenge Valuation shall be processed only after duly covering marks awarded in the previous Valuation. Such Answer books are then referred to the Examiners other than the Examiners /Moderators/ Chairperson involved in the Original Valuation of the scripts concerned. Such Examiners shall be chosen by the Vice-Chancellor for each Paper/Subject from a panel of Examiners submitted by the Registrar (Evaluation).

ORD-6: VENUE FOR REVALUATION/ CHALLENGE VALUATION.

The Venue for Revaluation /Challenge Valuation may be arranged either at the Revaluation / Challenge Valuation Cell in the University *or* as decided by the Registrar (Evaluation).

ORD-7: SCHEME FOR REVALUATION/CHALLENGE VALUATION.

The scheme for Revaluation / Challenge Valuation shall remain exactly same as the one used in the Original Valuation. No new scheme/ change in the scheme shall be allowed.

ORD-8: AWARD OF MARKS OF REVALUATION:

- a) The Original marks shall be retained in all cases, if marks obtained in Revaluation are lower than the Original Marks.

- b) The Revaluation marks shall be awarded as they are, if the marks obtained in Revaluation are more than the Original marks, but not exceeding 5% of the maximum marks of the Paper/Subject.
- c) The Candidate shall be given the benefit as per ORD-9 (b)+ (plus) half of the remaining difference of Revaluation marks if marks exceed 5% but not more than 15% of the maximum marks of the Paper/Subject.
- d) If the marks awarded in Revaluation exceed the Original Marks by more than 15% of the Maximum Marks of the Paper/Subject, the said Paper/Papers shall be referred to a Third Examiner and the average of the best two from marks obtained in Third Valuation (TV), Revaluation (RV) and First Valuation (FV) shall be considered.

ORD-9: AWARD OF MARKS OF CHALLENGE VALUATION:

- a) The Original Marks shall be retained in cases if marks obtained in Challenge Valuation are lower than the Original Marks.
- b) The Challenge Valuation Marks shall be awarded as they are, if the marks obtained in Challenge Valuation are more than the Original Marks, but not exceeding 5% of the maximum marks of the paper/subject.
- c) The Candidate shall be given the benefit of the difference of Challenge Valuation marks if marks exceed 5% and not more than 20% of the maximum marks of the paper/subject.

- d) If the marks awarded in Challenge Valuation exceed the Original award by more than 20% of the maximum marks of the paper/subject, the said paper/papers shall be referred to a third examiner and the average of the marks of third award and one of the earlier awards nearer to the third award shall be considered for the final award.

ORD-10: PROVISION FOR REFUND OF FEES:

- a) There is no provision for any refund of fees paid towards Revaluation of Answer Books irrespective of the marks obtained in the final award.
- b) There shall not be any refund of fees paid towards Challenge Valuation if the final Award does not exceeding the 5% of the maximum marks of concerned Paper/Subject.
- c) 50% of the deposit shall be refunded if final marks awarded in Challenge Valuation exceeding 5% of the maximum marks of concerned Paper/Subject.
- d) 100% of the deposit shall be refunded if final marks awarded in Challenge Valuation exceeding 20% of the maximum marks of concerned Paper/Subject.

ORD-11: ALLOWANCES FOR EXAMINERS, COORDINATOR AND SUPPORTING STAFF INVOLVED IN REVALUATION/ CHALLENGE VALUATION:

The Examiners, Coordinator and Supporting Staff involved for Revaluation / Challenge Valuation shall be paid TA/DA Or Local Allowance and Remuneration (Non-UGC Examiner and External Examiner) as per the University Rules.

ORD-12: PROVISION FOR APPEAL TO THE VICE-CHANCELLOR.

The Candidate if not satisfied with the award of Revaluation/ Challenge Valuation may make a Written Appeal to the Vice-Chancellor within 03 weeks from the

date of declaration of Revaluation/ Challenge Valuation results. Such an Appeal shall be submitted by paying double the Fees prescribed for Challenge Valuation. All such Appeals shall be referred to a Board constituted by the Vice-Chancellor that consist of at least 02 (Two) Experts from the Panel of Examiners.

The marks awarded by the Board shall be final. There shall not be any refund of fees paid towards this.

ORD-13: DECLARATION OF RANKS /GOLD MEDALS.

The University shall not announce Ranks / Gold Medals / Cash award until the completion of Revaluation / Challenge Valuation process.

ORD-14: TIME LIMIT FOR REVALUATION / CHALLENGE VALUATION.

The entire process of Revaluation / Challenge valuation shall be completed before the commencement of next Examination in the respective course(s). No result(s) shall be amended thereafter.

REPEAL AND SAVINGS.

The existing Ordinance regarding Revaluation /Review of Answer Books *or* any Ordinance *or* guidelines issued *or* adapted by the University for Revaluation/ Challenge Valuation are hereby repealed from the date of approval by the Syndicate of the University.

Provided that, the said repeal shall not affect the previous operation of the said Ordinance *or* anything duly done *or* suffered thereunder *or* affect any right, liability *or* obligation acquired, accrued *or* incurred under the said Ordinance.
